

ACKNOWLEDGEMENT OF RISK, WAIVER OF LIABILITY, RELEASE

In consideration of my minor child ability to participate in the go kart activities and any and all associated activities and events operated and hosted by Golf N Gator, LLC., Beachside Grand Prix LLC and Beachside Amusement Park LLC, (Collectively hereinafter to as "GNG") including, without limitation, driving, riding, racing, training, learning, practicing, competing, maintaining vehicles, observing, recreation of every type and description, and/or for any other purpose (hereinafter collectively "Events") and in consideration of my minor child's ability to enter into or upon the premises, locations, and facilities where said Events are or will be taking place, I, on behalf of my minor child, the child's representatives, agents, assigns, successors, heirs, and next of kin (hereinafter collectively "Guardian") hereby agree and represent as follows:

The Guardian hereby releases GNG and its owners, employees, contractors, permittees, agents, representatives, assignees, successors, heirs, volunteers, and other entities working for or with GNG, as well as its landlord of the property on which GNG is operating and its owners, employees, contractors, permittees, agents, representatives, assignees, successors, heirs, volunteers and other entities working for or with it (hereinafter collectively "Landlord") from any and all liability, loss, damages, costs, claims and/or causes of action, including but not limited to injury to the person or property and emotional and bodily injuries, including death, including without limitation any and all liability caused or occasioned by the sole or partial fault or negligence of GNG or Landlord, arising in any way from or related to the minor child's participation in any Events as herein described, the minor child's presence on, in, or about the premises where said Events are or will be taking place, and the minor child's use of GNG and/or Landlord's premises, facilities, equipment, and machinery.

The Guardian acknowledges that the minor child will be participating in activities, including but not limited to go carting activities which is inherently dangerous and which involve the risk of injury to person or property, including death. With full knowledge of the risks involved, the Guardian on behalf of the minor child hereby expressly assumes and accepts any and all risks of injury, death, damage, or loss that may occur as a result of the minor child's participation in GNG's activities or programs and/or the use of GNG and Landlord's premises, facilities, equipment, and/or machinery. The Guardian on behalf of the minor child hereby releases and holds GNG and Landlord harmless from liability for any such injury or damage, including any injury or damage that may result from GNG and/or Landlord's negligence and/or GROSS NEGLIGENCE and that may occur as a result of any emergency care provided, if any. The undersigned also hereby agrees to indemnify, save, and hold harmless GNG and Landlord from any liability, loss, damages, costs, claims and/or causes of action they may incur (including attorney's fees (including appellate fees) and court costs), arising out of or related to the minor child's participation in the Events or in any way related to the minor child's presence in or upon the premises where the Events are or will be taking place, including without limitation that caused by the negligence of GNG and/or Landlord and that occurred as a result of emergency care provided. The Guardian on behalf of the minor child also agrees to pay GNG for any and all damages to the premises, facilities, equipment, and/or machinery caused by the minor child.

The Guardian on behalf of the minor child acknowledges that the minor child will not participate in any Events or utilize the premises, facilities, equipment, or machinery if under the influence of alcohol or drugs or have a physical condition that would impair the minor child's ability to understand and follow directions and participate without creating risk to others or minor child. It is the Guardian's on behalf of the minor child responsibility to consult with a doctor prior to participation and to participate only in those activities for which the minor child has been cleared by his/her personal doctor, and possesses the required skills, qualifications, training and physical conditioning.

GNG reserves the right to deny participation to any person for any reason, including, but not limited to, failure to complete and sign this Acknowledgement of Risk, Waiver of Liability, and Release form, failure to follow GNG rules and regulations, failure to follow GNG and/or Landlord written or oral instructions/commands, display of actions or attitude that GNG deems to be detrimental to its business and/or other patrons, possession of banned or illegal substances, and engaging in unsafe or erratic behaviors/actions. In such an instance, GNG reserves the right to require that any person leave the premises immediately and without refund of any fees paid.

In the event of an emergency requiring medical care, the Guardian authorizes GNG to use its best efforts to obtain whatever medical treatment it, in its sole discretion, deems appropriate under the circumstances, and consents to the minor child receiving such medical treatment, if any. The Guardian acknowledges that GNG and/or Landlord shall have no responsibility to pay for medical treatment and related costs in any event.

The Guardian agrees on behalf of the minor child that the minor child may be photographed and consents to the use of any photograph, video, film, or likeness to be used by GNG and/or Landlord for any legitimate business purpose.

The Guardian on behalf of the minor child agrees that this Acknowledgement of Risk, Waiver of Liability and Release is intended to be and shall be construed as broadly and inclusively as is permitted by the laws of the State of Florida or other applicable laws, and that it is fully severable, such that if any portion is held to be invalid, the Guardian agrees that the balance shall nonetheless continue in full force and effect. The guardian also agrees that no oral or written representations can or will alter the contents of this document.

By signing this Acknowledgement of Risk, Waiver of Liability and Release, the Guardian certifies:

I HAVE READ AND UNDERSTAND THE CONTENT OF THIS ACKNOWLEDGEMENT OF RISK, WAIVER OF LIABILITY, AND RELEASE. I AM AWARE THAT BY EXECUTING THIS AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS ON BEHALF OF THE MINOR CHILD. THAT THE MINOR CHILD'S HEIRS, NEXT OF KIN, AGENT, ASSIGN, PERSONAL REPRESENTATIVES OR ADMINISTRATORS MAY HAVE HAD AGAINST GNG AND LANDLORD INCLUDING BUT NOT LIMITED TO GROSS NEGLIGENCE. I AM THE NATURAL GUARDIAN AND AT LEAST 18 YEARS OF AGE, FULLY COMPETENT, HAVE THE AUTHORITY TO EXECUTE THIS DOCUMENT ON BEHALF OF THE MINOR CHILD AND SIGN FREELY AND VOLUNTARILY. THIS RELEASE SHALL CONTINUE IN FORCE DURING THIS VISIT AND ALL FUTURE VISITS, UNLESS AND UNTIL REVOKED IN WRITING BY THE GUARDIAN.

NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF GNG AND LANDLORD USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT

BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM GNG AND LANDLORD IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND GNG AND LANDLORD HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.
